Sir/Madam,

I am directed to state that the Board of Governors considered the Assessment Report (04.09.2020) on the standard of examination and other teaching facilities available at Government Medical College, Ananthapuram for purpose of Recognition of MD(Microbiology) qualification for 04 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh and decided as under: -

"The Board of Governors considered the Council Assessor's Report (04.09.2020) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that MD(Microbiology) qualification for 04 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Government Medical College, Ananthapuram be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

You are therefore requested to notify the above qualification at the earliest.
